Failure to provide necessary support resources in line with crane availability may result in financial penalties and/or refusal of subsequent requests.**

***The use of cranes and cargo handling equipment not owned by Shannon Foynes Port Company is subject to a licence which can be obtained from the Company on request, together with details of charges.***

### Working Hours

Crane operations are available from 0600-2400 daily (including week-ends, Public Holidays (with the exception of Christmas Day), provided booking is made in writing at least 24 hours in advance and subject to availability and any other conditions which might apply. Extra charges will apply for an exceptionally large quantity of ships waste; it is the responsibility of the Ship's Agent to advise Shannon Foynes Port Company in advance of this special requirement.

### CARGO WASTE DISPOSAL

A charge of €0.048 per tonne (dry bulk) will apply. Furthermore careless handling in relation to dry bulk spillage on Port's internal road will be monitored by Shannon Foynes Port Company staff and will attract a surcharge. The surcharge will be determined by the cost of time spent and disposal charges.

### PARKING

A daily charge, or part thereof, per vehicle will be levied at the designated port parking areas in accordance with separately published rates.

### CONTAINERS

A separate charge sheet will be published for container-related activity.

### GRAVING DOCK

Permission to use this facility and related charges: discuss with Company.

### FERRIES

Charges for passenger and/or vehicle ferries plying within the Company's jurisdiction available separately from the Company.

### SPECIAL CHARGES

Shannon Foynes Port Company reserves the right to apply special charges where, in its opinion unusual cargoes, vessels or operations are involved.

### TERMS

Payment Terms Nett 30 Days from date of invoice; all trading subject to Shannon Foynes Port Company Terms and Conditions.
