



Marine Officer

Fixed Term 18-month contract

With a strong commercial mandate, Shannon Foynes Port Company has statutory jurisdiction over all marine activities on the Shannon Estuary – Ireland's largest portal area. The Company has a vacancy for a Marine Officer, who will work as part of the Port Services Team, servicing SFPC and third-party terminals within the Estuary.

Based in SFPC offices at Foynes, the role of Marine Officer primarily consists of outdoor duties, carried out at SFPC facilities and third-party terminals throughout the estuary, and involves working out of hours and at weekends on a regular basis. The work patterns may involve regular shift patterns to suit the needs of the business.

Candidates must have a proven demonstrable marine experience and a recognized Marine qualification, at a minimum an in-date P-boat license, or a DTTAS Deck Officer (Fishing Vessel) Certificate of Competency, or a DTTAS Certificate of Competency (Deck). In the absence of these qualifications' equivalent Naval qualifications or other significant relevant experience will be considered.

Excellent interpersonal, and communication skills, competency in I.T. (particularly MS Office) and the ability to work within a small team are important requirements. Experience of working within a formal risk management system and of Emergency Planning and Response are desirable.

This is a fixed term contract of 18 months duration which will be reviewed at the end of that period.

Key Duties will include:

- Regulating the arrival and departures of vessels to all marine facilities and berths throughout the Shannon Estuary
- Scheduling and coordinating shipping movements and services, along with some related administrative elements.
- The Marine Officer may also be involved in inspecting SFPC facilities; relief on SFPC floating craft; development and involvement in emergency response planning, training and coordination and there will be scope to identify and drive improvements in the broad range of activities involved in port operations.

Candidates must have:

- Proven demonstrable marine experience and a recognized Marine qualification, at a minimum an in-date P-boat license, or a DTTAS Deck Officer (Fishing Vessel) Certificate of Competency, or a DTTAS Certificate of Competency (Deck).
